Monthly Meetings: \$35 per month plus refundable cleaning deposit of \$150. No more than one two hour meetings per month.

Additional refundable deposit of \$100 for any event having alcohol. As long as there is no alcohol related damage the deposit will be refunded. Banquet permit is required at time of walk through.


Dumpster Days



ATTENTION DOG OWNERS:






SUMMER BREAK



Bicycle riders— please make sure your reflectors work or you have a light so you are more visible.






Car Owners- Check your front headlights and rear taillights to make sure that they are in working condition.

Winter is here- you may have plans to start construction and landscaping projects. Your friends at Puget Sound Energy want to remind you about the importance of calling 811 at least two business days prior to any digging. It is the law, and utility-owned lines are located for free.

Whether you are planning to use your employees or hire a contractor, start digging means calling 811 before each job. Outline your dig area in white paint so that the utilities will know where to mark. Even homeowners digging on their on property must call, if digging deeper than 12 inches.

Don't take a chance. Call 811 before you dig, then dig by hand within 2 feet of the markings.



6:35 PM Roll Call of Board: Tony Swy, Jennifer Celmer, Sherry O'Dell, Connie Ihringer. Crystal Detwiler, Cory Parsons and Dayna Brown

- 1) Discussion about pool heater: Members voted for a new pool heater in previous years; we do not have enough funds to purchase one at this time. The current heater works well right now but is overdue for replacement according to the reserve study. We are considering asking members to add to the pool heater fund at this next budget voting session so that when the current heater does go out we will have back-up funds so that we can order a new heater.
- 2) Employee wages: Discussion on how typical wage increases will be done, possible percentages to be given (like a cost of living)
- 3) Paint bids: (Outside of the Clubhouse) We have two bids from previous companies, we are considering allowing a General Contractor to also bid on this project.
- 4) Security Camera's: discussed the pros and cons of the Arlo 3. (vs other camera systems) need for the clubhouse and Pool area to start. Approved by members.
- 5) Contractor discussion for Clubhouse project: Connie and Dayna will work together to find General Contractors willing to make a bid on projects approved by members in past votes.
- 6) Breakdown of costs for new HVAC system (total of 30,600) between the clubhouse & office: need more information on how the numbers can be used. Will consider the General Contractor to help with this depending on the decision of the board regarding a contractor.
- 7) General Membership Meeting dates for both June and August meetings: discussed the General Membership meeting dates.
- 8) Discussion of what to do with old chairs inside the clubhouse. Discussed offering them for free to members during garage sale weekend and taking the leftovers to the dump.
- 9) Discussion of what to do with the old broken furnace inside the clubhouse. The broken furnace might go to the general contractor who we hire to work on the clubhouse.
