Open Board Positions: We still have 3 vacancies on the Board. We meet twice a month, meetings have been very productive and we feel we are getting a lot accomplished. However, the additional members would allow us to get more accomplished faster. Please come check out a meeting or two and see what is happening in our community and how you can help!!

Trees: We are quite aware of many trees in here that are dying,. We have had a tree service come check them out and have been informed they are not a hazard as of yet. There is no money in the current budget to remove these trees. Finance will be adding funds for tree removal to the September ballot so the association can have the trees removed before winter hits.

\$\$\$\$ Updates from Finance \$\$\$\$

Monthly Dues: We have heard a lot that our dues are too high compared to other HOA's—our dues are considerably lower here is a breakdown:

HOA Dues: \$40.95—this covers our employees, community areas, pool, clubhouse, river park, children's parties, pictures with Santa, annual picnic, etc.

Water System Maintenance Fee: \$14.87- this maintains our water system from the wells to the meter at your property.

Long Range Plan: \$8.07—this is State mandated to help cover repairs, upgrades of our equipment and community, so you won't get hit with a major assessment at any time.

1st Water Loan: \$12.36—voted on by the community to repair the tanks and lines when they found e-coli in our system.

USDA Loan: \$2.88—voted on by the community to repair the water lines in our cul de sacs. This contained the water loss the County was concerned about.

Monthly Total \$79.13 plus water usage

The 2014-2015 Budget planning is underway and as we discussed at the May Town Meeting, we are planning to raise our Long Range Plan to \$18./month to help with the cost of repaving our roads which are in dire need. This would be an increase of \$9.93/month.

As for you dues, we are looking at an increase and hope to have that information available at the next board meeting on Wednesday August 13th at 6:30 pm. We ask you to please come out and hear how much of an increase we are proposing and why.

River Park hours

the River Park is for members and their guests only

Any vehicle found in the River park lot without a Nisqually Pines Pass, will be towed at owners expense. Parking is allowed only in park, any vehicle on or near the road will immediately be towed.

Open year round 8 am to 7:30 pm approx.

Except July 1 - Sept 1, park is open till 9 pm

No lifeguard on duty - swim at your own risk.

No alcohol permitted on the premises.

No fires or over night camping!

Per Fish and Wildlife Dept. ONLY Catch and Release fishing is allowed on the Nisqually River!!

Burn ban is July 15 - Oct 15

Recreational fires only between these dates.

**Seasoned firewood only
during burn ban!**



You may not burn wood of any kind that is processed. You can burn wood purchased at the store. All wood has to be in its natural form.

If you have any questions, please call the office.

Fire may be no higher than 3ft. $\,$.

Noise Complaints

As an HOA we cannot enforce noise complaints. We rely on local law enforcement, as stated in 94.1.050. Please call the Thurston County Sheriff or Yelm Police Department.

Per the Thurston County Noise Ordinance, noise complaints need to be called into the police so they can determine if they are indeed breaking the law. If they are, they may be fined by the Sheriff or local enforcement as they are breaking the noise ordinance code and it is considered a misdemeanor.

We understand it is summer and people like to have their windows open and music or television turned up, however we ask you to be courteous to your neighbors!
